Subject: Summer Camps 2024 - economic benefits

Dear Families,

The Municipality of Parma has joined the **'Project for the fight against educational poverty and work-life balance: support for families to attend Summer Camps - 2024. PR FSE+ Priority 3 Social inclusion Specific Objective K'** approved by the Region of Emilia Romagna with DGR no. 365 on March 04, 2024.

Thanks to this project, families can apply for reductions on the registration fee in the Summer Camps for children aged 3 to 13 (up to 17 if with a disability certification according to Law no. 104/1992), if they meet the requirements specified in the call.

The Application for the request of the economic subsidy can be submitted may be submitted from 8:00 a.m. on April 23, 2024 until 11:59 p.m. on May 13, 2024 in the ON LINE form on the website of the Municipality of Parma at:

In order to proceed with the request for the subsidy you must be in possession of the SPID (Sistema Pubblico di Identità Digitale - Public Digital Identity System) credentials.

In the absence of it, you must obtain your SPID credentials by following the steps below:

A single application can be submitted **for each child**.

Once published, the ranking can be consulted on the website of the Municipality of Parma. An individual communication of the assignment will also be sent **via SMS** to the applicant's mobile number indicated in the application form.

Subsidies must be used in the chosen Summer Camps **not later than June 10, 2024**. After this date, all unused contributions **will be cancelled** and reallocated to families on the waiting list. **If allocations of financial contributions made in the absence of the requirements or on the basis of false statements occur after the controls of the Public Administration, the refund of the contribution awarded will be requested.**

Assignee families can register their children freely to one or more accredited summer camps by contacting the secretariats of the Summer Camps.
